SDFA Camp Code of Conduct

In order to ensure a safe, productive and sportsmanlike atmosphere for all our members, **everyone** who uses our facility **must adhere to our code of conduct**, and is expected to hold one another to these standards. **By using our facilities, you agree to abide by this code and be subject to its disciplinary provisions.**

We expect you to show respect for our campers, coaches, visitors, staff, facility and the rules of the activities. We expect you to be of good will with one another when differences arise and be generous and flexible as we strive to meet the needs of all of our campers. **Use of tobacco products, alcohol, and illegal drugs are prohibited on the premises.**

Yellow Cards

Campers **must** behave in a sportsmanlike manner at all times. Campers who continue to violate these guidelines after being told to stop will be required to sit out of activities for a period of time determined by the coach and staff. Parent/Guardian will be notified for fencers under age 18. This includes, but is not limited to the following specific prohibitions:

- **Swearing**
- **Name calling or negative talk**
- **Throwing equipment**
- **Hitting or kicking the floor or walls**
- **Yelling** (unless you just scored a touch – or thought you did)
- **Misuse of equipment** (including releasing the reel cords in the middle of the strip)

Black Cards

SUCH BEHAVIOR WILL RESULT IN A CAMPER BEING REQUIRED TO BE PICKED UP BY A PARENT OR GUARDIAN AND REMOVED FROM THE FACILITIES IMMEDIATELY AND INCLUDES, BUT IS NOT LIMITED TO, THE FOLLOWING SPECIFIC PROHIBITIONS:

- **Dangerously throwing equipment**
- **Willful damage to club property**
- **Dangerous or vindictive behavior/fencing**
- **Shouting matches**
- **Fighting**
- **Threats**
- **Extreme unsportsmanlike conduct**
- **Failure to follow the directive of the managers, coaches, or staff on duty**

Campers who are black-carded are subject to suspension from the club and will be prohibited from the use of the facilities. Refunds will not be issued for unused fees.
